#### The most important success and the factors contributing to this achievement

The training of 80 school mediators and the employment of 45 mediators in the educational institutions where are learning at least 15% of the Roma pupils. Factors that contributed to this achievement: - The existence of the legal framework that establishes the training and employment of school mediators; - The existence of a team of national trainers specialized in the training of school mediators; - Partnerships between the MNE and the Houses of the Teaching Staff in Constanta and Bacau.

#### The most important challenge and the factors contributing to it

The most important challenge was the elaboration of a methodology for monitoring school segregation. According to art. 23 of the Order prohibiting school segregation no. 6134 / 21.12.2016, the provisions of this order takes effects at the moment of adopting the methodology for monitoring school segregation. Between May and June 2017, during the 3 working meetings at the MEN headquarters, the working group for the elaboration of Methodology for monitoring school segregation met on the criteria stipulated in OMENCS no.6134 / 2016, to which World Vision Romania took part , The RENINCO Association, the Step by Step Association, the Coalition for Education, the Together Agency, UNICEF, the MEN National Council: DGEMIP, the Minorities Directorate, the ISE and ARACIP, in these meetings, the working subgroups for setting indicators and of the operational plan were established the criterias mentioned in Order 6134/2016, Art. 1, paragraph 2: • Criterion 1 - Ethnic or Mother Language Origin (Roma Federation, Romani Criss, Together Agency, CADO) • Criterion 2 - Disability and / or Special Educational Requirements (Reninco Association, Coalition for Education, WVR) • Criterion 3 - Socio-Economic Status of Families and the Residential Environment (WVR, ARACIP, ISE) • Criterion 4 - school performance of primary education beneficiaries (WVR, ARACIP, ISE + UNICEF + Pupils Council - specific to school performance The Segregation Monitoring Methodology is in work and will be completed by September 2018.

These norms are the basis for the elaboration of the applicant's Guide for Integrated Community Centers.
- 2. To support, under the conditions of the legislation in force, the Roma graduates with medical studies in order to employ them on the labor market (including in the Roma communities) by increasing the number of Roma employees with medical studies, including in the Roma communities. Thus, 7 of the health mediators who completed the post-secondary medical studies were supported by the local authorities through the transformation of the medical mediator who worked before completing the post-graduate medical studies as a community nurse to work in the same communities with the population of Roma ethnicity. At present, of the 1528 community nursing staffs, 7 are occupied by Roma community nurses.
- 3. Commitment of Roma community assistant and health mediator to Roma communities as a priority At present, the number of Community healthcare staff is 1528 Community nurses and 484 health mediators. Compared to 2015, the number of health mediators increased by 2017 by 90 new posts. Between 2015 and 2016, no request from local public authorities to set up new posts for community nurses and health mediators was refused. The number of new health mediators posts in the period 2015-2016 was 160, out of which 90 were occupied, the rest remained unoccupied because no persons interested in this activity were found. In the year 2017 93 new posts were requested but the approved budget provided only the payment of the existing staff at the end of 2016.



4. Developing the institutional capacity of health service providers at Community level Within the project RO 19.03 "Strengthening the National Roma Mediators Network for the improvement of the health status of the Roma population" within the RO 19 "Public Health Initiatives" program, a number of 45 health mediators have been trained and trained.

Work tools have also been developed for collecting data from Community healthcare staff (Community nurses and health mediators) which allows the collection of data from community healthcare staff in electronic format, which provides data visualization at both national and county level and separately for each locality. The project was implemented between June 2014 and April 2017 and had an allocated budget of 1633360 euro. The project had as partner the SASTIPEN Center for Roma for Health Policies. The general objective was to increase the access of vulnerable groups, especially Roma, to basic health services, paying particular attention to maternal and child health, reproductive health and control multi-drug resistant tuberculosis. The project introduced the concept of a new model of practice, that of the community team consisting of a community nurse and a health mediator.

A total of 45 community health centers, mainly in rural areas, have been operationalized and put into operation in 6 of the counties of Romania: Botoşani, Călăraşi, Dolj, Giurgiu, Gorj and Neamt. During the implementation of the project a series of information-education-communication campaigns were organized on topics that were considered as priorities in the evaluation studv carried out at the beainnina of the project. In 2017, the consolidation of the 45 community centers continued through the takeover of the community teams into the structure of the city halls from the 45 localities. Health promotion activities have been taken over under the National Health Promotion and Health Education Program, being extended nationwide in all 42 counties.

5. Monitoring the access of the uninsured Roma population to the minimal package of health services. In recent years there has been an increase in the number of Roma people who have had a minimum visit to the family doctor a year.

Thus, in 2016, the health mediators ensured services for 8924 children 0-1 year, 19,186 children 1- 5 years, 35,796 children 5-18 years old, 4777 pregnant women out of which 891 minor pregnant, 527 persons with TB. They worked together with the family doctor in 11,655 cases, the emergency service in 980 cases, the community medical assistant in about 7311 cases, and the social worker in 7973 cases

#### The most important success and the factors contributing to this achievement

A success was the fact that the responsible actors in this field met, discussed about the implemented activities, the results obtained so far, but also about the problems that still exist in this field. Thus, they had the opportunity to reflect on their own results and to conclude that progress is modest. Also, proposals and recommendations (financing, legislative modifications, etc.) have been formulated to lead to improvements.

#### The most important challenge and the factors contributing to it



An important challenge was the modest collaboration between the deconcentrated institutions participating in the consultation meetings and the ministries to whom they are subordinated, so that they felt helpless and the need to be guided and coordinated in specific activities; therefore, they requested assistance from NAR in areas and issues that NAR has neither expertise nor mandate.

### **Description of the measure**

#### Education

School inspectors for Roma education/ School inspectors for national minorities education are working within County School Inspectorates, according to the stipulations of the Strategy, however, in practice, the hiring and the tasks and responsibilities associated with this position differ, from one county to another. Thus, in some counties, school inspectors for Roma education of Roma ethnicity are hired and deal mostly with Roma education, while in others a school inspector for the education of national minorities is hired and who, in addition to other tasks and responsibilities, handles Roma education and in some counties the tasks and responsibilities regarding Roma education are carried out by a school inspector with concurrent positions (e.g. school inspector for technological education – concurrent positions-Roma education).

In the consultation meetings organized by NAR the need to evaluate the competences of the school inspectors for Roma education as well as the need for training, especially in the fields of diversity and non-discrimination have been addressed. Recommendations regarding the clarification of the status/role of the school inspectors for Roma education as well as for consolidating the cooperation between the school inspectors for Roma education and the experts on Roma from the County Offices for Roma have been sent to County School Inspectorates.

The main issues in education raised by representatives of County School Inspectorates - participants at the consultation meetings- refer to :

- Lack of after school programs in localities with a significant percentage of Roma children / students,
- lack of second chance primary and secondary school programs to allow Roma who left school early to complete primary / secondary education,
- the high rate of early school leaving among Roma students for various and multiple reasons,
- low number of school mediators employed in the educational system in relation to a large number of schools in which Roma students are learning and the school attendance is reduced
- the lack of intensive educational programs for Roma students to improve their school results and their results in national tests / exams, high school admissions

The School Mediator - an important resource for Roma students and their parents, with a positive impact on students, parents and teachers in the schools they work in, however there was no impact study on the beneficiaries, an assessment of their activity at national level, a study on the school mediation program, on this professional category.

Facilitating the access of Roma students to high school and higher education, as well as allocating special places for Roma students in high schools and special places for Roma students in college.



The Ministry of National Education sets aside annually special places for the Roma minority, but school inspectors reported that a significant number of these special places for Roma students remain unoccupied either because Roma students do not opt for these places or because they do not promote the national exam, or because many Roma children in rural areas do not continue their studies after completing secondary education (lower secondary education, 8 grades), for financial reasons, physical distance, etc.

Entrepreneurship. Employment and The presentations of the representatives of the County Agencies for Employment and County Progress Reports show that the main problem that occurs in the process of getting a job is the low level of education of a significant the adult seament of Roma. Organizing professional training courses / professional gualification courses is difficult because candidates must have a minimum level of education (graduates of either primary school or middle school), and in some poor communities, many Roma struggle with illiteracy. Specialists in this area of employment have suggested that NAR should propose to the National Authority for Qualifications a series of amendments to occupational standards, especially regarding the level of necessary studies, in the sense of reducing the level when members of Roma communities cannot attend courses due to the fact that they do not meet the required level of studies. The representatives of the County Agencies for Employment state that this institution does not have a special policy for the Roma, but it deals with the problem of employment from the perspective of vulnerability, does not collect data and does not have data from an ethnic perspective. However, it organizes information campaigns for members of the Roma community on vacancies, organizes job fairs for Roma, carries out mediation / accompaniment activities of Roma beneficiaries in the process of getting a job and organizes, within the limit of available funds, training / qualification courses to which Roma participants are also invited.

The discrimination of Roma by employers was reported by NGO representatives as a frequent practice and this phenomenon deserves the necessary attention. To this end, they recommended the County Agencies for Employment to organize anti-discrimination courses for employers, campaigns to promote anti-discrimination legislation.

Other deficiencies reported by representatives of the civil society referred to the lack of correlation of the County Agency for Employment between job offers and the level of training of the participants and the lack of collaboration of the County Agency for Employment with the School Inspectorates, as potential beneficiaries of qualification courses for jobs demanded on the labor market, not having the appropriate level of education, cannot continue their studies through second chance programs - designed and funded by County School Inspectorates. Participants recommended the development of an inter-institutional collaboration mechanism (County Agencies for Employment, County School Inspectorates, Local Authorities, etc.) aimed at increasing access to the labor market for vulnerable people with a low level of education.

Most Roma who obtain a job through the County Agency for Employment carry out unskilled jobs, often in construction, earning minimum wage. Participants believe that over 50% of Roma employees leave the job early because of extremely low income, increased workload and work time and finally because of forms of discrimination at the work place.

#### Health

The main issue raised by the participants in the NRA's regional meetings for consultation was the community healthcare program developed in vulnerable communities.

It is widely acknowledged the important role of the community health nurse and health mediator in the prevention of illness in vulnerable communities, but the legal framework for this program has several unclarities and deficiencies that negatively affect the work of these specialists. Thus, the following were mentioned: the ambiguities of the methodological framework for the functioning of the program, the poor coordination of the medical assistants and the health mediators from the Public Health Directorate - lack of human resources within the Public Health Directorate to monitor the work of these health care professionals, to provide technical support and to coordinate their activity, lack of coherent protocols for the implementation of the program at the local level between the Public Health Directorate and the Local Authorities, the lack of financial sustainability of the community healthcare program, the uncertainty of the role / position of the Health Mediator in the local authority organigram.

County Progress Reports highlight the fact that the main activities carried out in Roma communities are vaccination campaigns, health education campaigns to prevent illness, as well as other activities carried out by the Public Health Directorate in accordance with the national health programs managed by the Ministry of Health.

The Public Health Directorate does not carry out assessments of the needs of Roma communities from a health perspective, and therefore draws county action plans according to national public health programs for vulnerable communities. At the same time, there was a discussion about the lack of data specific to Roma communities, because the Public Health Directorate does not have ethnic databases, i.e. it cannot provide details about the more frequent diseases, the state of health of the members of the Roma communities. However, it has been



stated that considering that the state of health of individuals is influenced by diet, lifestyle, hygiene - economic factors, it is assumed that health in poor communities is more precarious and the incidence of illnesses is increased.

In 2017, one of the major health challenges was vaccination against measles, and in the context of these discussions, the need for collaboration has been highlighted, respectively between the Public Health Directorate and civil society representatives, Roma community leaders, health mediators and community nurses to develop information and conviction campaigns for child vaccination. The discrimination of Roma by the medical staff in hospitals is another issue raised by participants in the NAR regional meetings. To reduce these practices, the participants recommended NAR to propose to the Ministry of Health to reactivate the Ministerial Commission for Roma to implement a series of actions addressed to medical staff in the field of non-discrimination and equal access to health services for all citizens.

and Housing small infrastructure Housing is the field of activity in which few activities have been carried out, while needs are numerous, and expectations are high. The need to build social housing and necessity housing was highlighted in the consultation meetings, housing being one of the issues in which intervention is a priority. At the same time, aspects regarding the situation of the land that some Roma families built on, the situation of the construction permits, the documents on the ownership of the real estate and the land were mentioned. In this context, suggestions were made to NAR to initiate a housing assessment program in Roma communities to clarify and legalize the properties of families who have land and real estate but do not have ownership documents. The issue of identity documents was also mentioned, namely obtaining the identity document is conditioned by the proof of housing. In the absence of property documents, presenting evidence of housing becomes a challenge that some families cannot cope with. The County Offices for Roma do not have databases with communities requiring intervention to regulate the status of property documents, therefore NAR representatives have called for the involvement of the deconcentrated institutions of the National Agency for Cadaster and Property and the Joint Working Groups within the Prefectures to develop a database of these localities in rural areas, in order to be further advanced to the Ministry of Regional Development and Public Administration. Housing issues - infrastructure and access to utilities - are the responsibilities of local authorities, but either because of lack of financial resources or because of hierarchy of priorities, they have not made progress in the quality of housing in Roma communities. The participants recommended NAR to propose to the Ministry of Regional Development and Public Administration to develop a pilot program for poor Roma communities to provide them with access to appropriate utilities and infrastructure. In the session dedicated to housing, discussions and comments on Roma evictions were inherent. Starting from the eviction situation in Alba Iulia, continuing with the evictions in Constanta, Mangalia and Eforie, the experts from the County Offices for Roma mentioned that there are several Roma communities at risk of eviction, but the institutions present at these meetings have not identified solutions for these situations, the legislation being incomplete. As a result, the participants in the consultation meetings recommended NAR to propose to the Ministry of Regional Development and Public Administration a recommendation for accelerating and continuing the program of social housing for Roma, a program initiated by the Romanian Government. In the context of the evictions, the civil society participants have cautioned about the brutal ways of intervention of the competent bodies (gendarmerie, police, local authority) that emotionally affect the evicted families, especially minors. To prevent abuses and tense situations, recommendations have been made regarding the intervention of the competent bodies, the elaboration of an intervention protocol developed at a meeting of the County Office for Roma and the Joint Working Group, with the participation of Roma leaders.

#### Public administration – capacity and attitudes

The general opinion and shared by the majority of the participants in the regional consultation meetings, as well as by the experts from the County Offices for Roma, is that the local public authorities have little and ineffective involvement in solving the problems of Roma, some because they have no capacity (lack of human resources, financial resources, expertise), others either because they do not understand the importance of long-term inclusion of Roma, that this is a priority, or not assuming this responsibility.

Roma representatives, NGO leaders and workers have complained about the arrogant, defiant, discriminatory behavior and lack of respect against Roma from many City Hall officials. On the other hand, representatives of the local authorities have complained about the aggressive behavior of the Roma and lack of respect for the officials.

As a result, local public authorities need assistance to increase their capacity to intervene in the process of Roma inclusion, but also, assistance is needed for Roma communities and NGOs working with these communities to improve their communication and liaison with representatives of local public authorities.

NAR presented the collaboration with 4 County Councils in the Oltenia region, which resulted in the elaboration and adoption of action plans for the inclusion of the Roma for a period of 10 years.



Meeting participants and experts from the County Offices for Roma appreciated this collaboration and asked for assistance and support from NAR to replicate this example of cooperation, given the fact that County Councils are structures that have substantial financial resources and decision-making capacity concerning the setting of priorities and financial management. Local and inter-institutional partnerships, as well as with NGOs, have been encouraged so that projects and actions are initiated according to the real situation in the locality / county.

#### Results of this measure

Progress Reports of the Roma County Offices and Regional Meetings have highlighted problems and barriers in the implementation of the Strategy, at the level of the responsible institutions, regarding the capacities of the institutions and the attitudes of the officials. This stage is a necessary condition in the process of identifying solutions for streamlining the process of implementing measures that will contribute to the inclusion of the Roma. Problems have been reported regarding the structures - the institutions with responsibilities in implementing the Strategy, modest financial resources, reduced administrative capacity at the level of some local public authorities to manage the situation of Roma communities. etc • Regional meetings have created the premises and experience of a communication and collaboration process for monitoring and evaluation to develop recommendations, proposals for revising the Strategy,

Participants considered that NAR should moderate communication and collaboration between institutions, coordinate the monitoring and evaluation process. NAR should also propose completions and revisions to the Strategy, if the case and identify solutions to hold local authorities accountable in the implementation of the Strategy.

# Conclusion

#### Please summarise the main achievements for the year of reporting

The National Agency for Employment (ANOFM) has managed to secure employment for 4088 roma and to provide vocational training for 438 roma in 2017. Finalizing subprojects through which day services were set up; Implementing the Pilot Programme on granting a food-related support for preschool pupils and also for the pupils from 50 public preuniversity school units. All 50 schools included in this program have at least 15% Rroma preschool, primary and secondary school pupils.

- there were created 5 groups of kindergarten in Rromani language. there were created school curriculum of Rromani language and literature for the 5th and 8th grades and the school curriculum for Roma history and traditions for the 6th and 7th grades. were aorganised 5 national competitions (Rromani language, literary creation in Rromani language, Rroma history and traditions, ethnic and cultural diversity, interculturality), at which participated 682 rroma pupils. - 150 school teachers who activate within schools where the percentage of Rroma children is above 15%, who are trained to address the specific topics regarding the observation of the principles related to the inclusive school, of learning and implementing the elements related to the Rroma history and culture. -Comprising within the new curricula for secondary education, approved through the Decree of the Minister of National Education no. 3393/2017, of some competences, as well as some contents regarding the topic of diversity. There were continuosly submitted letters from MNe to county school inspectorates, with the aim at drawing attention to the school units regarding the necessity to not structure the segregated groups of preschool and school children (the starting classes, preparatory class, the I-IV grades and also the Vth grade), according to the Decrees of the Minister of National Education and Scientific Research 6134, 6158/Dec. 2016.
- Establishing the Working Group for elaborating the Methodology for Monitoring of the school inclusion/segregation.
- Establishment of indicators for the development of the Methodology for monitoring school inclusion / segregation.
- Elaborating at the level of County School Inspectorate and Bucharest Municipality School Inspectorate of the plans regarding the prevention of the school segregation on ethnic criterion for the year 2017-2018, based on the monitoring, at the initiative and also by direct contribution of the school mediators. -Seminar on the promotion and cultivation of the Rromani language, history and traditions within the preuniversity and the university education systemm and within interculatural environment, organized for 46 people by the Department of Interethnic Relations in partnership with the Minsitry of National Education, in November 2017. -MNF together with the Bucharest Municipality School Inspectorate had taken steps in order to establish bilingual classes. In the school plan for the school year 2018-2019 there was approved a bilingual high school education class (Romanian - Rromani) at Hristo Botev Theoretical High School in Bucharest. Were maintained the 42 parttime positions alloted to the inspectors for minorities/Rroma schooling and, in those counties where it is possible, full-time positions shall be established. In each county there is a Methodist for the language, history, In the school year 2017-2018 are working 430 school culture and for Rroma people schooling. mediators. - 80 new school mediators were trained (June 15-22, in Costinesti and in October 2017, in Bacău).
- In 2017 were hired 45 new school mediators. Between August-September there had been trained 50 educators, teachers for primary education, Rromani language teachers. In 2017 (for the university year 2017/2018), similarly to the previous years, there were allocated 650 funded places for the Rroma youth enlisted for the Bachelor Degree (more than 1% of the total number of students) and 325 distinct places for the Master Degree. As a novelty, 60 places for Doctoral studies were allocated for Rroma people.Ensuring sustainability for our project in the field of education. Determining the challenges faced by public institutions in activating the labor market for Roma;We observed a significant increase in the number of civil status certificates and the number of identity documents issued to Roma citizens during the last years, including the analyzed period (2017).In 2017,



Ministry of Internal Affairs allocated 79 places for Romanian citizens belonging to Roma minority, 50 of them being occupied. Compared to 2016, when only 44 seats were allocated, the situation in this thematic area has been substantially improved.Construction of the 300 housing units for Roma people;Fund allocation to the County Offices for Roma; Progress Reports of the Roma County Offices and Regional Meetings have highlighted problems and barriers in the implementation of the Strategy, at the level of the responsible institutions, regarding the capacities of the institutions and the attitudes of the officials. This stage is a necessary condition in the process of identifying solutions for streamlining the process of implementing measures that will contribute to the inclusion of the Roma. Problems have been reported regarding the structures - the institutions with responsibilities in implementing the Strategy, modest financial resources, reduced administrative capacity at the level of some local public authorities to manage the situation of Roma communities, etc. • Regional meetings have created the premises and experience of a communication and collaboration process for monitoring and evaluation to develop recommendations, proposals for revising the Strategy;

#### Please summarise the main challenges for the year of reporting

Getting the roma to register with the agencies for employment; Involving local communities in supporting children at risk;Establishing partnerships with governmental and intergovernmental institutions; Involvement of non-governmental organizations in implementing the measures of the National Strategy for the Improvement of the Situation of the Roma; Consulting the Roma community in prioritizing the implementation of measures in the National Strategy for Improving the Situation of the Roma Services for our projects are through public procurement applicable for social/cultural services. The main challenges were related to public procurement. Services for our projects are through public procurement applicable for social/cultural services. The main challenges were related to public procurement. There is a rather low interest of the persons concerned for claiming the ID documents or civil status registration papers.As a result of a broad consultation process with stakeholders and responsible actors, communication and collaboration constituted sensitive issues and sometimes different perspectives of understanding emerged that generated slightly tense situations. In the process of analyzing the stages of implementation, it was difficult to interpret the stages because of the non-unitary structure of county reports and of various and extremely different situations, extremely heterogeneous Roma communities, extremely varied attitudes and competencies / capacities of local public and county authorities regarding the situation of the Roma and the implementation of the Strategy. A dilemma reported by public institution representatives is related to the process and procedures of data collection. respectively, institutions claim that although legislation prohibits data collection on ethnic criteria, these data are required by central institutions as they are needed to substantiate strategies, policies, programs and projects for Roma and for monitoring progress and evaluating impact. This dilemma is a challenge that needs to be clarified by a specialist with legal expertise on data collection and protection. The non-unitary reporting in 40 counties, very diverse and different situations of the Roma communities at national level, the existence of resources and the different management capacities of the institutions create difficulties and strong discrepancies in implementation between the counties, therefore NAR - in collaboration with specialists in the field will identify ways to develop data collection tools and online platform for reporting- framework, so that reports present situations as balanced and as objectively as possible, allowing further centralization of data, analysis and interpretation of results, by sectoral areas. One major difficulty in this area is that the discrepancy between the health status of Roma minority citizens and health status of the general population is due to an interaction of multiple factors including poverty, lower levels of employment and education, poor living conditions, cultural factors and social exclusion. During the implementation process of National Health strategy, the most important challenge encountered until now was due to inefficient communication with Regional and local public authorities, incoherent law framework and lack of human resources in the community for jobs offered.

#### What were the main factors contributing to this and the lessons learnt?

The low level of education of the unemployed roma usually prevents them from accessing information in regard to the procedure for securing employment; Elaboration of a chart for the implementation of the measures of the National Strategy for the Improvement of the Situation of the Roma; Support provided by non-governmental and intergovernmental organizations; Bugeting of the measures in the Strategy; Support provided to school inspectorates and schools for local and county implementation of the measures of the Stategy.Service providers failed to fulfill legal conditions or were not interested in applying for public procurement; There is need to continue the activities carried out for the awarness of the Romanian citizens living in communities/groups with vulnerable persons. The consultation meetings were appreciated and considered useful. Participants considered that NAR should moderate communication and collaboration between institutions, coordinate the monitoring and evaluation process. NAR should also propose completions and revisions to the Strategy, if the case and identify solutions to hold local authorities accountable in the implementation of the Strategy.

Directions for action •

- Developing the capacity of local and county authorities in attracting resources, strategic planning and operational plans.



- Elaborating methodological norms for community workers, clarifying the positions / status and roles of the civil servants/workers employed for the inclusion of Roma, •Legislative proposals, amendments in areas that have been flagged as incomplete or with ambiguities
- Funding mechanisms, Negotiating programs and funding projects dedicated to poor communities to ensure a balanced development of localities / communities at national level
  - Information campaigns, anti-discrimination sessions for civil servants in the local and central public administration
- Developing data collection tools and developing a unitary format / framework for reporting for the County Offices for Romain order to development community care services, the Romanian Government approved the Emergency Ordinance no. 18/2017 on Community Care, which was approved by the Law no. 180/2017. The implementing rules of the Ordinance are developed and they are in the interministerial approval. The law aims to regulate the community healthcare in villages, towns, municipalities, Bucharest districts and the establishment, organization and functioning of integrated community centers, in order to facilitate and to improve access of the population, especially vulnerable groups, to healthcare services integrated with social and educational services. Community healthcare services, provided by community nurses and health mediators will be integrated with education and social services, according to the needs of the community and its particular profile (demographics, morbidity, socio-economic indicators etc.). The integrated teams cooperation model will be defined and regulated in the norms for implementing the Community Care Law. A standardized tool for data collection, analysis, planning, monitoring and evaluation of community healthcare services will be developed. It is currently piloted in 5 counties. The data collection tool is designed to integrate and share data in order to allow real-time interventions carried out by personnel from community healthcare and social services. To improve access of the population to healthcare services the best way for increasing the efficiency of interventions is represented by the organization of integrated community centers for an integrated approach to health, education and social issues.
